- During his tenure at Treasury, Weinberger was credited with being instrumental in the passage of the Taxpayers Relief Act, which resulted in the largest individual tax cut in decades, establishing a world-class management team in the Treasury's Office of Tax Policy, and improving Treasury guidance projects that helped reduce controversies and simplified taxpayer compliance.

Weinberger said that the inception of the advisory group demonstrated President elect Donald Trump's understanding that businesses have to work together, particularly in the wake of a divisive election campaign.

- However, he added that the President-elect was unlikely to experience a honeymoon period following his inauguration on Friday January 20, 2016.
